Task Forces of ,Bannu,Maran & Swat Circles in action.

240 direct hooks removed,Dozens arrested while Millions of Rupees recovered.

Task Forces actions against illegal use of electricity and Recovery of dues has been geared up throughout the Province. In this connection Task Force team in Bannu Circle checked various areas in Karak sub division and removed 10 hooks,recovered Rs.0.56 Million.Due to outstanding amount of Rs.0.47 2 transformers disconnected .During the operation teams of Lakki Division teams disconnected power supply to several areas due to nonpayment of Rs.0.67 Million.Similarly PESCO teams of Bannu 2 Division disconnected power supply due to non payment of Rs.1.70 Million to 3 transformers.Rs.0.26 Million has been recovered from defaulters.Bannu Rural Division teams removed 20 direct hooks,recovered Rs. 0.36 Million.Similarly PESCO D I Khan City teams disconnected power supply from one span.22 direct hooks removed and Rs. 0.89 Million has been recovered from defaulters.Similarly Taks teams of Tank Division disconnected power supply from 4 LT spans.FIRs against 2 persons has been lodged.21 hooks removed.Rs. 0.08 Million recovered from defaulters.Similarly Bannu Cantt sub division teams disconnected power supply from 4 transformers due to nonpayment of Rs.0.24 Million.

Similarly Task force of Mardan-1 Division disconnected power supply to Chamber kili,toru mera, from 8 spans,28 direct hooks removed.Rs.1.35 Million has been recovered from defaulters,Similarly Task forces of Mardan 2 disconnected power supply to Ghulama,jamal ghri,cham deri,pan deri,ghari kapora,muhib banda,katlang.FIRs has been lodged against 10 persons.Rs.0.68 has been recovered from defaulters.Similarly teams of Takhtbai division recovered Rs.2946679 from permanent disconnected defaulters and Rs.130437 has been recovered from running defaulters.Similarly PESCO teams checked several areas in Kohistan Pattan.Similarly PESCO teams of Bisham sub division hold a meeting with elders of Jamra about the dues and elders assured PESCO that all cooperation will be extended to PESCO in this regard.

Drive against illegal use of electricity and direct hooks will continue, PESCO has once again warned to stop power pilferage in the larger interest of the nation, due to which PESCO has to face financial losses & line losses on one hand and on the other hand PESCO's whole distribution system gets over loaded and the general public faces inconvenience of frequent power break downs.
